

Realized sales in September 2013 by the companies in the group of Eurohold

EUROINS INSURANCE GROUP (EIG)

The insurance holding EUROINS INSURANCE GROUP registered a 37 per cent decline in premiums (GWP) for September amounted to EUR 6.13 mm compared to EUR 9.78 mm for the same month of 2012. (Table 1.). Euroins Romania registered a decrease by 50 per cent due to the fact that the company has not made sales of MTPL insurances for 3 weeks under the ban by the Romanian Regulator. As a result of actions taken by the management, the process of sales resumption was conducted in the most beneficial way for the company and currently the premium income of Euroins Romania has already recovered to its previous levels. At the same time, in September Euroins Bulgaria registered a growth in all insurance lines except MTPL as a result of the followed company's policy during this year for insurance portfolio diversification.

For the first nine months of the current year the GWP of EUROINS INSURANCE GROUP registered a 6.9 per cent growth reaching EUR 118 mm compared to EUR 110 mm for January-September'2012, according to preliminary data. (Table 2.).

AVTO UNION

The automotive holding AVTO UNION registered a 62.7 per cent growth with total of 244 sales of new PC and LCV for September, 2013 compared to 150 units realized in September, 2012. The highest number of sales for the month was realized by Espace Auto (Renault, Dacia) with 89 units, followed by Nissan Sofia (Nissan) with 83 units, Star Motors (Mazda) - 42 units, Bulvaria (Opel, Chevrolet) - 23 units and Auto Italia (Alfa Romeo, Fiat, Lancia, Maserati) - 7 units (Table 3.).
