
In accordance with Article 69.1.1 in connection with Article 87.5.1 of the Act of July 29, 2005 on Public Offering, Conditions Governing the Introduction of Financial Instruments to Organized Trading, and Public Companies, Franklin Resources, Inc., with its corporate seat in Delaware, USA, being a parent company of Templeton Asset Management Ltd. and Franklin Templeton Investment Management Limited, hereby notifies that on 31 March 2016 there was a transfer of shares from the management of Templeton Asset Management Ltd., to the management of Franklin Templeton Investment Management Limited in Prime Car Management S.A., with its corporate seat in Poland (the "Company"), resulting in shares remaining above 5% of the total votes in the Company.

Before the transfer of shares, clients and funds managed by Templeton Asset Management Ltd., in the aggregate, held 836,044 shares in the Company, constituting 7.02% of the share capital which represented 836,044 votes, constituting 7.02% of the total votes.

After the transfer of shares to the management of Franklin Templeton Investment Management Limited, clients and funds managed by Templeton Asset Management Ltd., in the aggregate, held 526,165 shares in the Company, constituting 4.42% of the share capital which represent 526,165 votes, constituting 4.42% of the total votes and shares held by clients and funds managed by Franklin Templeton Investment Management Limited, in the aggregate, held 311,299 shares in the Company, constituting 2.61% of the share capital which represented 311,299 votes, constituting 2.61% of the total votes.
