

## Extraordinary announcement of

ENEFI ENERGY EFFICIENCY PLC.

pursuant to the Ministry of Finances Regulation No: 24/2008. (VIII.15.)

**ENEFI Energy Efficiency Plc.** (the "Company") hereby notifies its reputable Investors that the Municipality of Gheorgheni has instituted legal actions against the affiliated companies of the Company in Gheorgheni, requesting the suspension of the notice of the Company terminating the concession agreement and the declaration that the municipality - as opposed to its previous information - has voted for the price increase requested by the service provider.
