Notice according to section 93 para 2 Austrian Stock Exchange Act (*BörseG*)

BUWOG AG: Change in stake of voting rights of BlackRock, Inc.

BlackRock, Inc. notified on 10 June 2016 pursuant to section 91 et seq. Austrian Stock Exchange Act that BlackRock, Inc. and its controlled undertakings crossed a reporting threshold on 09 June 2016 and have a relevant interest in 3.954.998 shares of BUWOG AG or 3.96 % of the voting rights of BUWOG AG. Thus, BlackRock, Inc. fell below the reporting threshold of 4%.
