**Notice according to section 93 para 2 Austrian Stock Exchange Act (*BörseG*)**

**BUWOG AG: Change in stake of voting rights of FMR LLC**

FMR LLC notified on 22 July 2016 pursuant to section 91 et seq. Austrian Stock Exchange Act that FMR LLC and its controlled undertakings crossed a reporting threshold on 22 July 2016 and have a relevant interest in 4,883,773 shares of BUWOG AG or 4.89% of the voting rights of BUWOG AG. Thus, FMR LLC crossed the reporting threshold of 4%.
