NOTIFICATION ON A SIGNIFICANT BLOCK OF SHARES IN A PUBLIC COMPANY

In accordance with Article 69.1.1 in connection with Article 87.5.1 of the Act of July 29, 2005 on Public Offering, Conditions Governing the Introduction of Financial Instruments to Organized Trading, and Public Companies, Franklin Resources, Inc., with its corporate seat in Delaware, U.S.A., being a parent company of Franklin Templeton Investments (ME) Limited, Templeton Asset Management Ltd., and Templeton Asset Management (Poland) TFI S.A. (the "subsidiaries") hereby notifies of a transfer of shareholdings on 9 August 2018 in shares held in Prime Car Management S.A. with its corporate seat in Warsaw, Poland, (the "Company").

Before the transfer of shareholdings, shares under the management of Franklin Templeton Investment Management Limited and Templeton Asset Management Ltd. represents in total 837,464 shares of the Company, constituting 7.03% of the share capital which represent 837,464 votes, constituting 7.03% of the total votes.

After the transfer of shareholdings, shares under the management of the subsidiaries represents in total 841,209 shares of the Company, constituting 7.06% of the share capital which represent 841,209 votes, constituting 7.06% of the total votes.

There has not been a significant change in the aggregate shares and votes held that would require a subsequent notification by Franklin Resources, Inc. The notice is being lodged as a result of the change in the subsidiaries that manage the shares in the Company as detailed below.

- (i) Franklin Templeton Investments (ME) Limited represents 309,879 shares in the Company, constituting 2.60% of the share capital which represents 309,879 votes, constituting 2.60% of the total votes.
- (ii) Templeton Asset Management Ltd. represents 526,165 shares in the Company, constituting 4.42% of the share capital which represents 526,165 votes, constituting 4.42% of the total votes.
- (iii) Templeton Asset Management (Poland) TFI S.A. represents 5,165 shares in the Company, constituting 0.04% of the share capital which represents 5,165 votes, constituting 0.04% of the total votes.
